INVITATION OF PUBLIC COMMENTS

Subject: NHAI, Madurai Region - Highway Administration - laying of cables under PIU, Karaikudi - Permission for laying of pipeline by M/s. Trichirapalli City Coporation, Trichy Across highway (i) Km 134.620 on Trichy Bypass road section of NH67 & 45B in the State of Tamil Nadu - **Invitation of Public Comments - Reg.**

The Proposal is regarding permission for laying pipeline Across highway (i) Km 134.620 for a length of 60m on Trichy Bypass road section of NH67 & 45B in the State of Tamil Nadu by M/s. Trichirapalli City Coporation, Trichy.

- 2) The Right of Way is 60 m in the aforesaid stretch by M/s. Trichirapalli City Coporation, Trichy has proposed to lay the pipeline at the edge of the ROW for a length of 60m and across the highway at 01 location, which is in conformity with Ministry's guidelines vide letter No.NHIII/P/66/76 dated 19.11.1976.
- 3) Further M/s. Trichirapalli City Coporation, Trichy has mentioned that the pipeline across the NH at a distance of 20 m from the top of the pipe is 1.20m below ground level.
- 4) M/s. Trichirapalli City Coporation, Trichy has furnished an undertaking to the effect that the applicant will remove the laid pipeline in future if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that M/s. Trichirapalli City Coporation, Trichy will also restore the surfaces to its original condition soon after removal of the OFC lines. Also, certified that the proposed Optical Fiber Cable work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
- 5) As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the proposal submitted by the applicant will

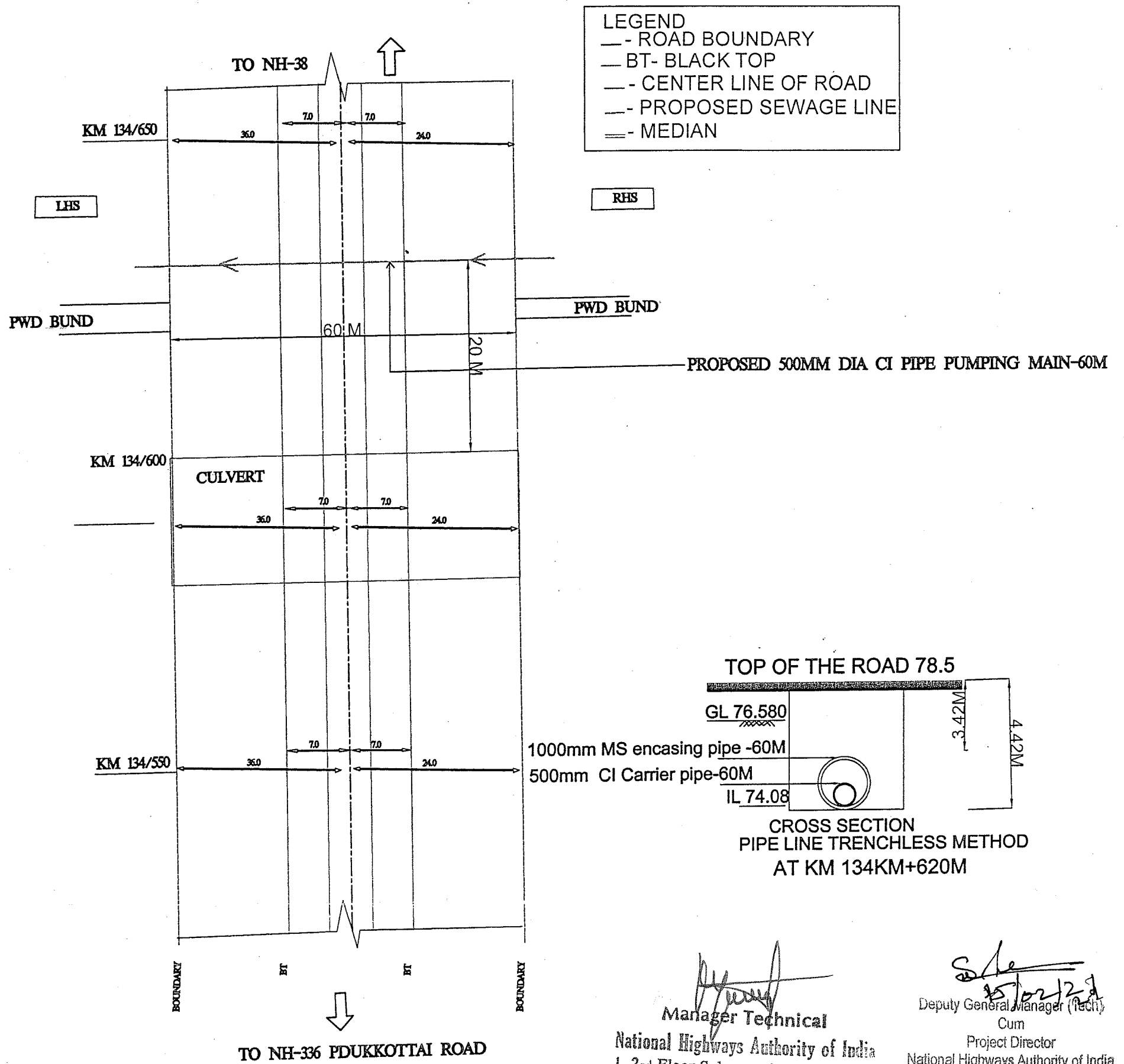
