- 2. The Right of Way in the stretch of NH proposed for underground 16" dia Multi Product pipeline is varying from 12.0m to 20.00m. The carriageway width of stretch from Km 4/000 to 10/200 of NH 381A (Vellakovil-Muthur) is varies from 7.00m to 10.50m. M/s Bharat Petroleum Corporation Limited has proposed to lay the underground Public Utility at edge of the ROW for a length of 6200m by adopting open trench method along the National Highway.
