SUB: Six Laning of Ahmedabad to Vadodara section of NH-8 from Km. 6.400 to Km. 108.700 (Length 102.300 Km.) and Improvement of Ahmedabad-Vadodara Expressway from Km. 0.000 to Km. 93.302 in the State of Gujarat (Length 93.302 Km.) under NHDP Phase V on Design, Build, Finance, Operate & transfer (DBFOT) Toll Basis.

- Proposal seeking ROW permission for laying of 125mm Dia Gas Pipeline along NH-48 from Km 55+990 to Km 58+500 on Ahmedabad-Vadodara section of NH-48 in the state of Gujarat.
