

SA Infrastructure Consultants Pvt Ltd vide ref 2nd cited informed that they had observed the Checklist, Drawings, Undertakings, Draft Agreement are found in order and recommended for approval of Competent Authority to accord permission for laying of water pipeline at subject cited locations.  - b) Checklist is in accordance to MoRT&H Guidelines is enclosed for laying of water pipeline on NH land and the same is found in order.

 - d) Construction of Methodology for laying of water pipelineby HDD method & open trench method is enclosed.

As per para 2.5.2 MoR&TH guidelines dated 26.06.2020." Proposal was verified and recommended by Manager (T) and certified as below:

- i) Open Trench method is proposed along NH-16 from (i)Km.1032+800 to Km.1036.505-3.705 Kms on RHS and Horizontal Directional Drilling method (HDD) is proposed across NH-16 at Km.1032+800 at Ashram Hospital, Eluru Rural & DenduluruMandal, Eluru district on Gundugolanu-Kalaparru section on NH-16 in the state of Andhra PradeshAndhra Pradesh.
