With reference to the subject cited above, M/s. MNGL(Maharashtra Natural Gas Ltd. Vide letter 1st, 5th and 6th cited has submitted proposal for laying of steel natural gas pipeline of 273.1mm of OD from Km. 399/800 to 406/800 from Ramayampet (NH-44) to Bhiknoor on NHAI road (NH-44).

The proposal furnished by M/s. MNGL has been forwarded to Independent Engineer the Independent Engineer vide reference 3rd cited has furnished report and recommendations on the proposal.

The details are as follows:

- The above proposed location is located from 399+800 to 406+800 RHS
- The available ROW from 399+800 to 406+800 is 60m
- The Road crossing proposed by the applicant at Km 406+700 from RHS to LHS for a length of 60 m. as shown in the drawing

The applicant has proposed two methods for laying of Gas Pipeline

a. One Method which is Open Trench Method of 1.2m depth from Ground Level with bottom width of 400mm for laying 273.1mm dia of steel pipe for laying of Pipe line along the National Highway.

b. Another method which is Horizontal Directional Drilling method (HDD) with a depth of 2.5m. from the Road Top level for providing 273.1mm steel pipe.

M/s MNGL submitted the strip plan/ route plan and the check list enclosed are verified and found in order.

- Restore the locations in as is condition after the completion of the work along with backfilling and cleaning or removal of debris, losse earth produced due to execution of trenching away from the Right of Way (ROW).
- The Applicant has to take prior approval from the forest department, if in case any plantation planted by the Forest Department has to disturbed.
- The trees in the Green belt area should not be cut.
- It is responsibly of the applicant to not to damage the other utilities. If damaged then it is the complete responsibility of the applicant to restore in as is condition.

Based on the recommendations of Independent Engineer, M/s. MNGL submitted the proposal.

- The proposal was submitted through online portal and it application no. 20240129/1/12/21359/4479.
- Bank Guarantee for an amount of Rs. 17,40,000/- furnished by the agency and obtained confirmation from the concerned Bank (copy enclosed).
- License fee for an amount of Rs. 21719/- has been paid through Bharathkosh portal (copy enclosed).

The proposal has been processed and verified in accordance with MoRT&H Circulars, dtd. 07.08.2013 & 22.11.2016 and the agency M/s. TGCL has furnished the following:

- Checklist
- License Deed
- Undertakings for Relocation of gas pipelines as and when required
- Methodology of laying Gas pipeline






