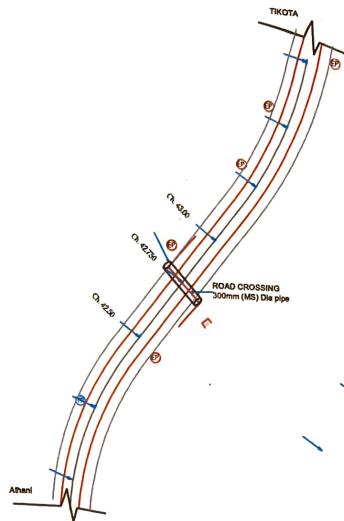

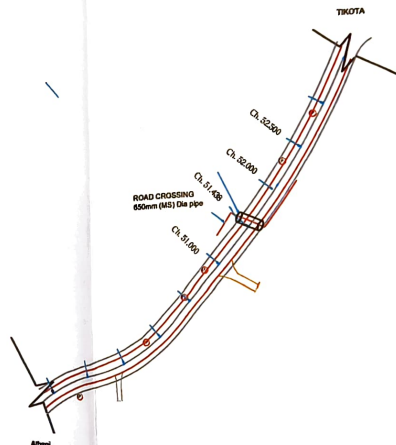

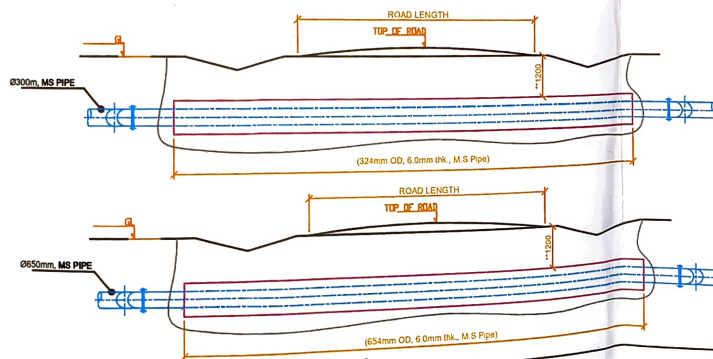

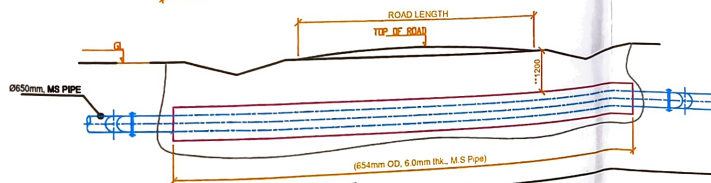
PLAN VIEW
ROAD CROSSING-01



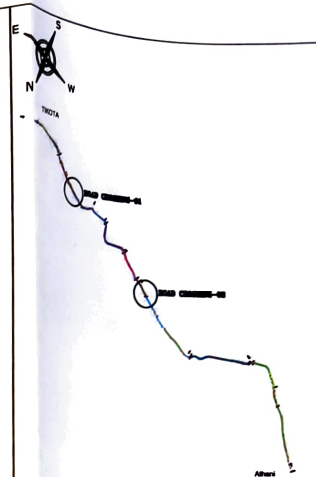
PLAN VIEW
