Subject:- Permission for access to proposed Retail Outlet abutting NH-151at km 08/633 (between Km 08/613 to Km 08/6523), left hand side at Block/Survey No. 90 at village Navi Sankli, Taluka Jetpur, District Rajkot in the State of Gujarat.

2. The subject proposal was submitted on Ministry's website on 26.05.2018 and was sent vide this office letter dated 04.06.2018 to PD, NHAI, PIU- Rajkot for examination.

3. As per inspection report submitted by concerned PD there is median opening and village road (RHS) at distance 278 mt against 300 mt. Further, the case is meeting all the parameters of the guidelines except for the criteria of median opening and location of village road.

Therefore the oil company vide letter dated 13.07.2018 has asked this office to consider case as per relaxation in guidelines for access permission along National Highway circulated vide letter no. RW/NH-33023/19/99-DOIH dated 16.03.16.
