It is to inform all concern that Project Director, NHAI, PIU-2 Nagpur vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Yavatmal has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that Project Director, NHAI, PIU-2 Nagpur along on Wardha-Butibori Section of NH-361 in the State of Maharashtra is as follows:

- Laying of 33 KV Cable from km Ch. 491.250 to Ch. 507.550 on NH-361 (Total length 16.30 km) (Overhead 15.48 km & underground 0.820 km).
- Alignment of the cable is along Wardha-Butibori Section on NH-361.
- 07 nos of Crossing by HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
