With reference to the subject cited above, it is to submit that the E.E., Construction, TSTRANSCO, Sangareddy, in the reference 1st cited has submitted proposal regarding permission for Erection of 132KV DC/SC Line (0.646 km) from loc. No.78/23/3 of existing Medchal Manoharabad line to M/s. Mahalakshmi Profiles Pvt. Ltd near Kallakal village, NH-44 crossing between chainages 460/4 and 460/6 near kallakal village on Nagpur-Hyderabad Section of NH-44 in the state of Telangana.

- The proposal was referred to the Independent Engineer for furnishing their comments/ recommendations. The Independent Engineer vide reference 3rd cited has furnished the recommendations for the said proposal duly informing the following:
  - > The proposed line is crossing the Highway at km. 460+550 in between km. 460+400 to km. 460+600.

> Towers are being erected at an offset of more than 8.5 m from ROW.

> As per 5.1 of IRC-32-1969, the Horizontal clearance shall be at least 10 m away from the nearest edge of the road way and the Horizontal clearance given in the proposal is 14mtrs away from the nearest edge of the road way.

> As per Transco Memo dated 04.09.2008, minimum vertical clearance for electric power lines shall be 12.5 mtrs. Vertical clearance for the power line from the lowest conductor to road FRL given in the proposal is 17.4 mtrs.

> As per applicable Indian Electricity rules1956, minimum ground clearance for 132 KV is 10.7 m.

> As per 4.2 of IRC: 32-1969, guard cradle or screen should be provided for the electric power lines carrying voltage exceeding 110 Volts. Hence, it is recommended the Agency to provide guard cradle or screen for the same.

- > The agency has furnished undertakings for required safety, protection and structural stability.
- 3. As per the recommendation of the IE the proposal was verified in this office and following are submitted:
  - a. M/s. Mahalakshmi Profiles Pvt. Ltd. has submitted undertakings as under:
    - i. During the Six lane or further development works of NH-44, M/s. Mahalakshmi Profiles Pvt. Ltd. would re-locate the transmission lines at their Own cost as per instructions of NHAI.
    - ii. M/s. Mahalakshmi Profiles Pvt. Ltd. would pay or compensate for the damage caused to the NHAI property, as per the directions of the PD, PIU, NHAI, Nirmal, during the execution of the above work.
    - iii. M/s. Mahalakshmi Profiles Pvt. Ltd. would take the responsibility in case of any accidents or any incidents due to lack of safety measures on National Highway during the execution of the above said work.
  - b. As per section 23 of (2) / 38 (1) of National Highway act 2002, the Highway administration or the officer authorized under sub section may on application made by a person in this behalf and having regard to the safety and convenience of the traffic, grant permission to such person.
  - c. In the event of any cable snapping or an emergency, the agency shall give an undertaking to ensure that the safety of the road users is not compromised. The contact details of the concerned nodal official and the rapid response team shall be given to this office and also the PD PIU NHAI. An information board to this effect shall be set up on the NH in the ROW for public information.
- 4. The proposal was verified in this office as per the recommendation of the IE and in accordance with IRC: 32-1969, standards for vertical and horizontal clearances of overhead electric power lines and is found in order.



This has reference to the subject and letter in ref (2) cited above wherein PD, PIU, Nirmal requested IE to examine the proposal of EE, Construction division, TSTRANSCO with regard to grant of permission for stringing of transmission lines crossing between chainage Km: 460.400 to Km 460.600 near Kallakal Village.

In this regard, the proposal has been examined duly inspecting the said location and found in accordance with IRC:32-1969, standards for vertical and horizontal clearances of overhead electric power lines and the other observations of IE are as follows.

- The proposed line is crossing the Highway at Km.460.550 in between Km.460.400 to Km.460.600.
- Towers are being erected at an offset of more than 8.5 m from ROW.
- As per 5.1 of IRC-32-1969, the Horizontal clearance shall be at least 10 m away from the nearest edge of the road way. And the Horizontal clearance given in the proposal is 14mtrs away from the nearest edge of the road way.

- As per Transco Memo dated 04.09.2008, minimum vertical clearance for electric power lines shall be 12.5 mtrs. Vertical clearance for the power line from the lowest conductor to road FRL given in the proposal is 17.4 mtrs.
- As per applicable Indian Electricity rules 1956, minimum ground clearance for 132 kv is 10.7 m.
- As per 4.2 of IRC:32-1969, guard cradle or screen should be provided for the electric powerlines carrying voltage exceeding 110 Volts. Hence, it is recommended the Agency to provide guard cradle or screen for the same.
- > The agency may please be requested to furnish necessary work program/methodology for stringing of conductors/crossing the highway at Kallakal village.
- > The agency may please be requested to coordinate with M/s Mahalakshmi Profiles Pvt Ltd, the concessionaire while carrying out the stringing activity.
- > Due care shall be taken for smooth and uninterrupted flow of traffic during the activity.
- > The agency has furnished undertakings for required safety, protection and structural stability.

In view of the above, since the submitted proposal is found in order, the Authority may accord permission for stringing activity duly obtaining consent and an undertaking from M/s Mahalakshmi Profiles Pvt Ltd for relocation of the Electrical tower with its own cost in case if NHAI desires to carry out the capacity augmentation/ future widening of Project Highway.
