SUB: Short Term Improvements & Routine maintenance of Surat-Vapi Section from Km. 263.000 to Km. 381.000 on NH-48 in the state of Guiarat

Proposal seeking ROW Permission for laying and crossing of 400mm Diameter Pipe 800mm Diameter MS Pipe, 900mm Diameter Pipeline Trench Underground Drinking Water Pipeline laying along (i) from Km 302+150 to Km 305+650 on Both Sides parallel and (ii) Crossing on NH-48 at Km 303+970 in Kharel Village, Taluka-Chikhli, District-Navsari, for Drinking Water Supply Pipeline Under Chikhli Part-2 RWSS by M/s. GWSSB, in the state of Gujarat.
