- SUB: Four laning of Dhrol-Bhadra Patiya Section of NH-151A (Between Ex. Km 5+700 to Km 13+600 of SH-25) and Bhadra Patiya-Pipaliya Section of NH-151A (Between Ex. Km 73+000 to Km 44+800 and Ex. Km 38+350 to 24+000 of CSH-6) in state of Gujarat through Public Private Partnership (PPP) on Hybrid Annuity Mode.
 - Proposal seeking ROW permission for crossing of NH-151A at Km 50+060 by 11KV Electric U/G Cable Line for Electrification of HT Connection of M/s. PANKH 7 CERA LLP at Village-Kharachiya on Left Hand Side, from Amran to Maliya Roadin in the state of Gujarat.
