### Invitation of Public Comments

**SUB:** Construction of 6-lane access-controlled highways from 4+888 to 35+000 of Rajasthan/Gujarat Border to Santalpur section of NH-754A as a part of Amritsar-Jamnagar Economic Corridor in the State of Gujarat on EPC Mode under Bharatmala Pariyojana (Phase-1) (AJ/RGBS/Package-1): Proposal for permission for laying 11KV 3C X 240 Sq.mm XLPE cable connecting proposed Piluda Solar plant to 66/11KV Dudhva (GETCO) substation, underground for crossing Amritsar Jamnagar NH 754-A at chainage 18+900 (Ch. 857+717 of Amritsar Jamnagar) District-Banaskantha to M/s. Vector Green New Energies Private Limited.
