INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Accomodation of Public and Industrial Utility Service along National Highways-Laying of 200mm DI Pipe from Km.6+000 to Km.6+736 (LHS) including crossing at Km.6+736 by Kerala Water Authority on NH-85-Reg.

The proposal is regarding permission sought by Kerala Water Authority for laying of 200mm DI Pipe from Km.6+000 to Km.6+736 (LHS) including crossing at Km.6+736 by KWA on NH-85 (through Open trench/HDD) in the State of Kerala.

- 2. KWA has furnished undertaking to shift the pipeline at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.
- 3. Further, KWA has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KWA has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Kerala Water Authority will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
