It is to inform all concern that Executive Engineer, MJP, Yavatmal vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that MJP, Yavatmal along on Wadner-Kelapur-Pimpalkhuti Section of NH-44 in the State of Maharashtra is as follows:

- Laying of pipeline along Highway from (1) km 143.700 to km 155.260 (2) km 155.260 to km 163.440 (3) km. 163.440 to km 169.200 using HDD method.
- Crossing at (1) km 152.470, (2) km 154.720 (3) km 156.800, (4) km 158.170 (5) km 166.070 (6) 168.705 through HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
