

Sub: Proposal for grant of permission for laying 33 KV overhead line and UG cable from Ch. 518 to Ch. 522 at Addl. Butibori Industrial area – Reg.

It is to inform all concern that M/s Maharashtra Industrial Development Corporation vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Yawatmal has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Maharashtra Industrial Development Corporation along on Wardha-Butibori Section of NH-361 in the State of Maharashtra is as follows:
 - Underground 33 KV Cable from km Ch. 518 to Ch. 522 on NH-361.
 - Alignment of the cable is along Wardha-Butibori Section on NH-361.
 - Cable to be laid in Duct 1.8m below ground level.
 - Crossing by HDD method at Chainage 517.870 & 522.400.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 28.01.2016 due to above transmission line on the subjected stretch.
