Sub: Four laning of Hungund-Hospet section of NH-13 from km.202.000 to km.299.000 in the state of Karnataka under NHDP Phase-III on DBFOT Toll basis permission for laying of pipeline in NH corridor- Providing and constructing water supply pipeline from foreshore of Narayanpur reservoir in Krishna basin to BTPS plant (approximate length 171 kms) of which 340,400 to Km.342.180 and Km.3472.680 to Km.342.900 on NH-50 ROW of which 2.0 Kms - Reg.

The Project Director, PIU, Hospet vide letter cited (2) & (3), has submitted the proposal of M/s. Karnataka power corporation Ltd., Ballari, for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the laying of water supply pipeline along NH road from 340.400 to Km.342.180 and Km.342.680 to Km.342.900 on NH-50 ROW for a length of 2.0 kms of NH-50 in the State of Karnataka.
- 3. As per para-4 of Ministry's Circular No. RW/NH-33044/29/2015/S & R (R) dated 22.11.2016, the Highway Administration shall be put out in the Public Domain for 30 days for Seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
- In view of the above, the comments/objections of affected public is hereby invited with reference to Ministry's circular dated 22.11.2016 for the above mentioned proposal. 
In view of the above, it is hereby once again requested that the subject proposals may please be accorded approval on hard copies only at an early date.

Vide references 1st cited above, M/s. Karnataka Power Corporation Ltd., Ballari has submitted proposal for granting permission for laying of pipeline in NH corridor – Providing and constructing water supply pipeline from foreshore of Narayanpur reservoir in Krishna basin to BTPS plant (approximate length 171 Kms) of which 2.0 Kms to be laid on LHS of NH-50 ROW in the above subject reach.
