 - Proposal seeking ROW permission for laying of underground 315mm Dia HDPE Pipeline across NH-47 (Godhra to Gujarat/MP Border section) at Km 154+300, Near Village-Piplod, Taluka-Devgadh Baria, District-Dahod in the state of Gujarat.
