### Invitation of Public Comments

**SUB:** Proposal seeking ROW permission for crossing of 400mm Dia DI Pipeline across NH-41 at Km 321+750, in the Samakhiyali-Gandhidham section under Augmentation to Bhachau RWSS Scheme of GWSSB, in the state of Gujarat.
