Methodology:

1) Utilized NH land area = length of pipeline to be laid X dia of pipe. (1 Sq m =0.0247 Dismil) D.IPipeline.

2) Performance Bank Guarantee = running length of pipeline X rate per Meter (Rs 100/- for pipe <300mm Dia Pipe line & Rs 250 /- for pipe >300 mm Dia < 1000 mm dia Pipe line and Rs 500 for pipe > 1000mm)
