The proposal is regarding permission for laying of water supply pipeline across NH at Km 306/700 in Padalur - Trichy section of NH-45 in the State of Tamil Nadu for SRV Matriculation Higher Secondary School at Samayapuram was submitted to this office by PD, PIU, Trichy vide letter No. NHAI/PD/TRY/Utility/ NH45/OFC/2020/152 dated 24.02.2020 in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the Joint Secretary, SRV Matriculation Higher Secondary School, Samayapuram, Trichy for laying of water supply pipeline across NH at Km 306/700 in Padalur - Trichy section of NH-45 in the State of Tamil Nadu for SRV Matriculation Higher Secondary School at Samayapuram as detailed under;

- 3) The Right of Way is 60m in the aforesaid stretch. The Joint Secretary, SRV Matriculation Higher Secondary School, Samayapuram, Trichy has proposed to lay water supply pipeline across NH through *HDD Method* at a depth of 1.35 from the bottom of the ground which is in conformity with Ministry's guidelines vide letter no. NHIII/ P/66/76 dated 19.11.1976
- 4) The Joint Secretary, SRV Matriculation Higher Secondary School, Samayapuram, Trichy has furnished an undertaking to the effect that they will remove the laid of water supply pipeline in future if required by NH Authority at any time for expansion

of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipe line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
