
2. The alignment proposed by that M/s. Jio Digital Fiber Pvt. Limited along NH-161 Akola-Washim-Hingoli-Nanded Road from Naka washim 80+600 to 81+500 Near Washim Bus Stand, Venketesh hotel washim, Single side Total length 900 Mtr. in the State of Maharashtra is as follows:

- Underground Optical Fiber Cable from km. 80+600 to km. 81+500
- Alignment of the cable is along Akola-Washim-Hingoli-Nanded Road from Naka washim to Near Washim Bus Stand, Venketesh hotel washim Section of NH-161.
- Cable to be laid along highway in trench in utility corridor.
- Cable to be crossed by HDD method at Km. 81+500.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
