**Sub: Proposal for grant of access permission to retail outlet of M/s Nayara Energy Ltd.(Formerly known as M/s Essar Oil Ltd.) between Ch. 206+293 to Ch. 206+338 on NH-79(Khasara No. 898) at village- Ganeshpura, Tehsil- Chittorgarh, District- Chittorgarh in the state of Rajasthan.**

M/s Nayara Energy Ltd. i.e. the applicant vide letter no. EOL/Mangrol/01 dated nil has submitted a proposal to this office on above captioned subject. This office has forwarded the proposal to PD PIU NHAI, Chittorgarh for site investigation vide this office letter dated 27.09.2018 and PD PIU NHAI Chittorgarh vide letter dated 16.01.2020 has submitted required report. The proposed retail outlet proposal on 7.00m wide of NHAI, proposed service road on proposed 6 lane of NH-79, if proposed service road not constructed by NHAI, then the service road will be constructed and maintained by oil company at their own cost. In this regard a undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.
