Sir,

M/s Jharkhand Urja Sancharan Nigam Limited vide letter referred at Sl. No. (i) has submitted their proposal for obtaining NOC for crossing of 132 KV D/C Saria-Bishnugarh Transmission Line in between Km. 337.350 & 337.400 of NH-2. The proposal submitted by them has been scrutinized by this office & comments are enumerated hereunder :-

1. The span length has been kept 215.76 M, which is sufficient enough to accommodate the proposed six laning of existing carriageway. The proposed ROW for six laning is 60 M at the crossing location.
2. The Vertical clearance shown in submitted drawing is 13.9 M between Road Level and bottom conductor of transmission line, which is more than 8.6 as per Indian Electricity Rules, 1956. Therefore, it is satisfying the criteria of minimum vertical clearance.

Since, the proposal submitted by Jharkhand Urja Sancharan Nigam Limited is satisfying the criteria, laid down vide Indian Electricity rules, 1956 and therefore, it is hereby recommended that necessary approval may please be granted for O/H crossing of 132 KV D/C Saria-Bishnugarh Transmission Line in between Km. 337.350 & 337.400 on NH-2.
