Permission to lay OFC in NH-43 (Chandil) to (Bharat Project Phase-II) of

Bharat Broadband Network Limited (BBNL) for providing broadband connectivity to Panchayats (A Part of Digital India) from 206.00 to Km 218.00

Sir,

This has reference to your office letter dated 20-11-2019 mentioned above vide which NHAI-RO-Ranchi has forwarded proposal of laying optical fibre cable from 206.00 to Km 218.00 and Km 231.00 to Km 246.00 of NH-33 (total Km 26.00) to examine the case in accordance with MoRT&H Circular dated 22-11-2016. In this regard it is to intimate that presently stretch from Km 206.00 to Km 217.300 (15.300 Km) of NH-33 is under this office.

Accordingly, this office vide letter dated 21-11-2019 had requested AE-M/s Theme Engineering Services Pvt Ltd to examine the said proposal in light of MoRTH guidelines. AE-M/s Theme Engineering Services Pvt Ltd vide letter dated 05-12-2019 has examined the proposal and reported that proposal seems to be in accordance with MoRT&H Circular. AE-M/s Theme Engineering Services Pvt Ltd has further intimated that no objection for laying of said optical cable may be issued considering compliance of the following requirements apart from the statutory requirements:-

- 1. The work shall be taken up with prior intimation to the Concessionaire/Contractor with the programme of work.
- Lay of PLB pipes for taking of OFC may be done by HDD method only. 2.
- 3. Pipes for OFC shall be laid at a depth not less than 1.65m from ground/road level.
- 4. Pipes shall be laid at the extreme edge of the ROW as far as possible.
- No HDD pit shall be provided in the carriageway portion. 5.
- 6. Any damage of the road shall be made good as per specification and requirement of the Concessionaire/Contractor as laid down in the Contract/Concession Agreement.
- 7. In case cable is to be taken on the structure methodology may be specified and consented in advance.

In view of the above, the proposal is forwarded with recommendation for issuance of No Objection Certificate for laying of said optical cable considering points mentioned above.
