Subject: Access Permission for laying of underground OFC of 12.5 mm dia with HDPE protection pipe of 40 mm of M/s. Gujarat Fibre Grid Network Ltd along NH 47 in intermittent stretches from Km 83.600 to Km 182.000 (L=42.4 Km) and 12 crossing across NH 47 in District-Surendranagar and Rajkot in the State of Gujarat.

The Roads and Building Department, Government of Gujarat vide letter cited under reference has recommended the subject cited proposal for the permission for laying underground OFC of 12.5 mm dia with HDPE protection pipe of 40 mm of M/s. Gujarat Fibre Grid Network Ltd along NH 47 in intermittent stretches from Km 83.600 to Km 182.000 (L=42.4 Km) and 12 crossing across NH 47 for approval of the Competent Authority.
