The NOC for laying of transmission main and feeder main for providing 3rd stage water supply scheme to Mandya City Under AMRUT along NH-275 sought by KUWS&DB was submitted by this office vide letter cited under reference(1) was returned by your kind self with some observations vide letter cited under reference(2) the same was forwarded by this office to the AEE NH Sub Division Malavalli vide this office letter cited under reference(3) . The AEE NH Sub Division Malavalli has submitted the compliance to the observations as under.

Sl No	Observations	Compliances.
I.	The proposal is submitted for laying of transmission main and feeder main from KM 235 to 237.60Km, Km 258 to 260.300 & Km 260.70 to 262.500. However, the license fee and Bank Guarantee calculated is not as per the proposal. This needs to be clarified and reconciled. Further,	The licence fee and Bank Guarantee was calculated as per the MORT& H guidelines Circular No RW/NH-33044/29/20155&Rdated 33.11.2016 by obtaining the land value from the concerned sub-registrar. The licence fee for crossings was not considered in the earlier proposal. The same is once again verified and accordingly calculation of fees to be paid are worked out and enclosed in Annexure-I .

	crossing is also proposed at two locations & these should also to be considered while calculating the License fee and Bank Guarantee. Also, three more crossing are shown at Pandavapura which is not mentioned in the proposal. This needs to be clarified.	<p>There are 2 crossing at km 235.00i. Manjus holiday resort at Welcome Board, Kiragandur ie 257Km and Bank Guarantee for the said crossings are also considered in rental/license fee calculation. There are no crossings at Pandavapura.</p> <p>The license fee will be obtained from user Department while concluding the agreement.</p>

ROW details are not shown in the drawings	The width of the road, ROW and distance from the Centreline of the road and location proposed for water/supply are marked and enclosed in the proposals submitted earlier. However the same marked copy in Google image is also enclosed here with once again.
III.	The calculation towards Performance guarantees as per Para 6 of the Ministry's guidelines dated -22.11.2016 shall be furnished, along with a copy of the Bank Guarantee.	A Bank Guarantee for an amount of Rs.16,85,00/- (At the rate of Rs.250/Rmt for 4.14+2.6Km ie 6740Mts) is already submitted by M/s KUWS&DB, vide BG No. IPBG01391800003 dtd -20.03.2018.
IV.	The cross sectional drawing is not as per standard drawing of above said Ministry's guideline	The cross sectional drawing as per Ministry's guide is herewith enclosed.
V.	The agreement as per the format of the above said guidelines needs to be submitted.	The agreement will be submitted after clearance from your end and before issuing of NOC.
VI.	The proposal including the drawing needs to be verified/certified Executive Engineer, NH Division	The drawings are signed.


