## Invitation of public comments

Sub: Proposal for access permission for existing retail outlet of M/s BPCL on NH-62 at ch.694/470.00 to 694/615.90) in survey no/Khasra no 1093 & 1097 (Additional land khasra no.1093/1,1094/1,1096/1 & 1097/1) of village-Bagsin, Tehsil-Sheoganj, Distt-Sirohi in the State of Rajasthan.

M/s. BPCL ie. the applicant vide letter even dated 27.11.2017 has submitted a proposal to this office on above captioned subject. The applicant has already been granted Final NOC from MoRTH vide letter no.RW/NH-12017/07/2011/PS-4/RJ dated 24<sup>th</sup> June,2011. There exists a toll Plaza which was to be constructed at 1214.30m from the existing retail outlet but due to deviation in National Highway Upgradation plan it was constructed later at 935m from the inner wall of the retail outlet which has been agreed by PD PIU NHAI-Jodhpur vide letter no.13031/1/2018/NOC-Others/1552 dated 25.07.2018. Now the oil company has applied for extension of retail outlet on opposite side of the toll plaza ie: maintaining the minimum distance of 935m from the inner boundary of retail outlet to the center line of the toll plaza. The applicant has sought relaxation for minimum distance from the toll plaza, as per Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. Since this is the case of existing retail outlet having some extension on the opposite side of toll plaza, this office is of the view that the oil company should be given relaxation for grant of access permission on the extent policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per From A (copy enclosed) on below mentioned address.
