



Adverting to the above subject Bharat Gas Resource Limited Mumbai have submitted their application for granting Permission for laying steel Gas Pipeline along/across NH-50 (Bidar to Humnabad Section) from Dhumansur to Humnabad Maniknagar ie from km 97.00 to 100.00 in Humnabad town, Bidar Dist,Karnataka vide cited at ref (1) above.

The existing alignment of NH-50 from Km 96.40 to 100.85 passes through Humnanbad town limits. Here, city Bypass alignment has been approved and land accusation for bypass road is in advance stage and pending for payment of land compensation. So, the existing NH from 97.00 to 97.75 Km on RHS side and from Km 97.75 to 100.00(L.H.S) side has been identified as suitable place for laying gas pipeline. Tender has already been invited for widening of NH-50 from two lane to four lane from Km 100.00 to 100.85 and actual widening work will be started soon. Details of pipe laying proposal across/along NH-50 is shown below.
