Sir,

Guidelines regarding procedures to be adopted for invitation of tenders and qualification of Contractors for execution of Road and Bridge works on National Highways and Centrally Financed Schemes were issued vide Ministry's circular dated 27.11.2009 and amended vide addendum dated 16.03.2010 & 21.05.2010. The matter has since been reviewed in the Ministry in the light of performances and outcomes observed in the past years and following has been decided with the approval of the competent authority.

- (i) Bids / RFQ for the works costing upto Rs. 100 crores may be invited by state PWD /BRO using the requisite bidding document & procedure applicable for subject work.
- (ii) Bids/ RFQ for the works costing more than Rs. 100 crores shall be invited in the Ministry by the concerned Superintending Engineer of the project zone/ Regional Officer of the Ministry / Project Director PIU of the Ministry in the state.
- (iii) The opening and evaluation of Bids / RFQ shall be done by the evaluation committee as mentioned below:

(A) Projects costing more than Rs. 5 crore and up to Rs. 25 crore:

(i) Chief Engineer (National Highways) of the concerned State - Chairman PWD / equivalent
(ii) Regional Officer, M/o Road Transport & Highways dealing - Member with the State concerned
(iii) Superintending Engineer (concerned NH Circle), State PWD - Member
(iv) Executive Engineer (concerned NH Circle), State PWD - Member

Chief Engineer (National Highways) of the state PWD / Project Director PIU shall enter into contract agreement with the lowest bidder, within 10 (ten) days in conformity with EPC bidding document.
