The proposal seeking access permission to the above retail outlet of M/s. IOCL was submitted by Oil company vide letter No. Nil dated 13.06.2014 (Annexure - I). The proposal is verified and certified by Project Director, NHAI, PIU, Hospet vide letter dated 28.10.2014 (Annexure - II). After examining the proposal this office vide letter of even no. dated 27.11.2014 had accorded Provisional NOC and issued layout plan (Annexure - III). In the meanwhile, this office received a Legal Notice from Shri Sirajin Basha, Advocate regarding violation of norms (Annexure - IV). Reply to the Legal Notice was submitted to Shri Sirajin Basha, Advocate after the draft reply was approved by Ministry vide letter dated 15.05.2017 (Annexure - V). Further, the copy of the Legal Notice was also forwarded to DGM(T) & PD, NHAI, PIU, Hospet, for his comments vide this office letter of even no. dated 07.02.2017 (Annexure - VI). DGM(T) & PD, NHAI, PIU, Hospet has submitted the comments vide letter dated 17.02.2017 (Annexure - VII). Now, Oil Company vide letter dated 29.01.2018 (Annexure - IX) has requested to accord extension of NOC under relaxation, since the construction of the retail outlet is not completed within the stipulated period.

2. Since the construction of the retail outlet is not completed within the stipulated period, the proposal necessitates relaxation.

3. As per the guidelines issued by the Ministry vide OM No.RW/NH-33023/19/99-DO-III dated 16.03.2016 (Annexure - X), the relaxation application will be made available for public comments and the comments will be invited within 60 days from the day of uploading. The comments needs to be submitted in the Format enclosed as Form- A.

Its upkeep and strengthening of the box drain (if required) should be carried out by executive agency and the expenditure for the same will be borne by the applicant. An undertaking may need to be given to this effect.	The Existing Box Drain will be strengthened to the required specifications of the IRC and the undertaking for the same is been enclosed.
iii)	As there exists enough space beyond the box drain, chevron markings may also be provided keeping in view of the road safety aspect.	Noted and the chevron markings are provided.
iv)	On the issues of distance of 5.5 m wide road and toll plaza and their confirmation to Ministry's norms, clarification is being sought from the Ministry. Please refer to your letter dated 06.12.2013 submitting therewith a proposal for issue of NOC for 'Access Permission' to construct New Retail Outlet at the location mentioned above. The proposal has been examined in light of the Ministry's Circular No.RW/NH-33023/19/99-DO-III dated 24th July, 2013 and the Ministry has 'No Objection' for the issue of "**Provisional NOC**" subject to the following terms and conditions:

- (i) The applicant should adhere to their undertaking given with the proposal.
- (ii) The applicant may construct the Access Road, scrupulously according to the approved drawing enclosed with the proposal **at their own cost within six months**. Any discrepancy, would lead to violation of Ministry's guidelines and the approval issued shall stand cancelled.
- (iii) After the construction as per approved drawings and to the satisfaction of the Highway Administration, the final approval will be given after the receipt of communication from the applicant about the completion of construction work and License Deed may be signed by the Competent Authority (i.e. Highway Administration). In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.

- (iv) Further, it is intimated that as per Ministry's Circular vide para-4, before obtaining approval from this office, the Architect/Consultant will also ensure video recording before and after completion of construction work stating that the work is executed as per the approved drawing. Therefore, the same may be furnished.
- (v) This office may be immediately informed, if there are any changes in the land documents, power of attorney etc. with respect to the details already submitted with the proposal.
- (vii) A copy of the proposal alongwith **Approved Drawings**, is enclosed herewith for taking further necessary action.

50 (Old NG-13) Sholapur-Chitradurga Section).

The proposed Fuel Station as detailed above is not in
accordance with existing norms and guidelance as of
Apendix-I.


1. As per the general condition of siting 4.7, Note, the
Fuel station would not be located within the distance of
1,000 Meter from any barrier that of Toll Plaza. But,

here, the distance is only 700 Meter from the proposed Fuel station. Even the toll plaza is on the main carriage way and the proposed site is on the serviced road, the entry to the service road is in between the toll plaza and the proposed site. So the 1 K.M. norm from toll plaza will apply. It is wrongly represented that the access to the proposed site is from the service road only not with the main carriage way.

2. As shown in the location plan of Fuel Station, very important fact that the intersection with MDR is at 180 Meters from the proposed location, but as per the norms there should be a minimum of 1 K.M. distance the Existence of MDR is shown as rural road which is a clear misrepresentation.

My client hereby calls upon you, to take stringent measures if violation and non-compliance of the condition stipulated in sites and cancel the license of the Fuel Station.

Since, the entry & exit to retail outlet is from the service road, there is no hindrance to the through traffic.
- (ii) The intersection road with MDR which is at a distance of 180m from the proposed location of the retail outlet also joins the service road. Therefore, the traffic on this intersection also does not affect the traffic on the main carriageway.

Sub: Guidelines/norms for access permission to Fuel Stations, Private Properties, Rest Area Complexes and such other facilities along National Highways- reg.

The power to give for access to National Highways lies with the Highway Administration as per the Highway Administration Rule, 2004 under the control of National Highways (Land and Traffic) Act, 2002. While exercising this power, the Ministry issued the general guidelines/norms for access permission to fuel stations, private properties, rest area complexes and other facilities vide Ministry's Circular No. RW/NH-33023/19/99-DO-III dated 24.7.2013. The norms and guidelines were issued as per enclosures of the Circular at Appendix-I (along with Annex-I, II & III to Appendix-I) and Appendix-II (along with Annex-I, II and III to Appendix-II).

2. The Ministry has been receiving many cases of relaxation from the Ministry's norms stipulated in the Circular under reference. It has been observed that many cases of deviations from the extant guidelines, specifically distance from intersection, gap in central median, distance from nearest fuel station, distance from toll plaza and non-fulfillment of the criteria of construction within a year of issuing NOC have been received for relaxation by the Ministry. Further, many complaints and RTI applications against relaxation have also been received in the Ministry.

3. In view of the above, it has been decided that the application for relaxation in the guidelines/norms for access permission to fuel stations, private properties, rest area complexes and other such facilities along National Highway will be filled up by the applicants through online forms and will be submitted to the concerned Highway Administrator. Before the issue of provisional NOC and in principle approval, the Highway Administrator will make available in the Ministry's website (morth.nic.in) the complete application for public comments, thereby bringing out the relaxation sought by the applicant. Comments will be invited within 60 days

from day of uploading and will be in the format as enclosed as Form-A. The Highway Administrator will subsequently take the decision on the application in a speaking order for accepting or rejecting the relaxation sought and taking into consideration the objections received on the matter. The applicant may have a further period of 30 days for appealing against the Highway Administrator to the Appellate Authority who will be the Chief Engineer of the respective Project Zone in Ministry of Road Transport & Highways. Chief Engineers will take into consideration the application of the applicant seeking relaxation, the objections received from the general public and the speaking order of Highway Administrator to decide on the appeal. The order of the Appellate Authority shall be final.

4. The Highway Administrator will issue the 'in principle' approval and the Provisional NOC for the applications, where relaxation of norms has been sought, only after the completion of the process illustrated in the preceding paragraph.

5. This circular will be read in continuation with circular of Ministry dated 24.7.2013 mentioned in first paragraph. The other provisions of the earlier circular will remain applicable.

6. The competent authority in the Ministry shall notify the Appellate Authorities for their respective Highways Administration. The contents of this Circular may be brought to the notice of all the concerned in your organization.

7. This issues with the approval of the competent authority.
