Invitation of public comments

Sub: Proposal for construction of an approach by clustering with an existing BPCL Pump through service road & slab culvert with iron grating for a proposed retail outlet of IOCL at Km.307.601 (307.583-307.618) (LHS) abutting on Jagdalpur-Dhanpunji road Section on (Old NH-43 & New NH-30) at Kh. No.22/1, 20, 21 PH. No.24/52, Village Markel, Tehsil-Jagdalpur, Distt-Bastar Chhattisgarh.

The CE (NH), PWD, Raipur vide letter no. 705/W/CE/NH/ Raipur, dated 05/04/2019 has submitted a proposal for NOC for the construction of an approach road and slab culvert in respect of retail outlet mentioned in the subject above. The applicant has sought relaxation from Ministry's norms stipulated in circular No.RW/NH-33023/19/99-DO.III dated 24.07.2013 for deviations in required distance from an intersection with rural road, existing retail outlet of BPCL at 192 m & another BPCL retail outlet on the other side.

2. The Oil Company has requested for relaxation in view of para above. The justification towards relaxation is placed at Annexure-I.

3. As per Ministry OM vide No.RW/NH/33023/19/99-DO.III date 16.03.2016, the Highway Administration will make available the relaxation proposal of Oil Company for public comments, and the comments will be invited within 60 days from the day of uploading. Accordingly, the above relaxation proposal is being uploaded on the website of Ministry and Road Transport and Highways (www.morth.nic.in).
