#### Invitation of public comments

Sub.: Rehabilitation & Up-gradation of Raebareli-Banda Section of NH- 232 (New NH-31/335)- Proposal for granting permission for overhead crossing of 132KV SC line on DC Tower Sareni-Dalmau Overhead High Tension Transmission Line Over National Highway- 232.- Reg.

The Executive Engineer, Electricity Transmission Division, U.P. Power Transmission Corp. Ltd., Raebareli has submitted the proposal for NOC for overhead crossing of 132 KV line in the subject cited stretch.

- From the submitted proposal, it is seen that the height of both proposed structures (Transmission Towers) on which the proposed overhead line is hanging is 32.025 m and 37.025 m. The structures (Transmission Towers) on either side are being erected at distance of 55 m & 141 m respectively from the centre line of National Highway. Further, the minimum clearance of 15.50 m between the lowest conductor of the proposed line and NH carriageway shall be maintained. However, the proposed transmission line shall be crossing the National Highway at 84 degree.
- by the Ministry vide OM No.RW/NH-As per the guidelines, issued 33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained
