Invitation of Public Comments

Sub: Request of NOC for installation of Stainless Steel Bus Shelter on NH-709B and NH-334B proposed by Sh. Satyapal Singh, Hon'ble Member of Parliament, Lok Sabha Constituency, Baghpat - Reg.

The Project Manager, Provisional Co-Operative Construction and Development Limited (P.C.C.D.), Hapur has submitted a proposal of request of No Objection Certificate (NOC) for installation of 24 Stainless Bus Shelter along NH-709B and NH-334B proposed by Sh. Satyapal Singh, Hon'ble Member of Parliament, Lok Sabha Constituency, Baghpat.

2. From the submitted proposal, it is seen as per the checklist that stainless steel bus shelters has to be installed at 24 locations along NH-709B & NH-334B with a utilized NH area of 290.4 sq.m. (12.1 sq. m. X 24 = 290.4 sq.m.). The proposal of installation of stainless steel bus shelter is after a distance of 3 meter from main carriageway before the utility corridor in the available Right of Way (ROW). The highway configuration of NH-709B (EPE Crossing to start of Shamli Bypass) is 4 lane with paved shoulder and 2 lane/4 lane with paved shoulder of NH-334B (Meerut to Haryana border via Baghpat).

3. Further, undertakings has been submitted by Provisional Co-Operative Construction and Development Limited (P.C.C.D.), Hapur that they will not damage the property of National Highway and the agency will not hamper the traffic movement along with ensuring all safety measures while executing the work.

4. As per the guidelines, issued by the Ministry vide OM no. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

5. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the days from the date of publication beyond which no comments shall be entertained.
