Sub:- Proposal for permission to lay underground water conductor system for Hydro Electric Project (Pallivasal Extension Scheme 2x30MW) by Kerala State Electricity Board Limited at Km.163.500 (Crossing) of NH-85 (old NH-49) in the State of Kerala- reg.

The proposal is seeking permission by Kerala State Electricity Board Limited for laying underground water conductor system for Hydro Electric Project (Pallivasal Extension Scheme 2x30MW) crossing at Km.163/500 on NH-85 (Old NH-49) submitted to this office in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The proposal by the Kerala State Electricity Board Limited to lay the underground water conductor system for Hydro Electric Project (Pallivasal Extension Scheme 2x30MW) crossing at Km.163/500 on NH-85 (Old NH-49) is as under:

The Executive Engineer, Head Works & Tunnel Division, Pallivasal Extension Scheme, Kerala State Electricity Board Ltd., Munnar has proposed to lay the underground water conductor system for Hydro Electric Project (Pallivasal Extension Scheme 2x30MW) crossing at Km.163/500 on NH-85 (Old NH-49) by open trench method.

The Executive Engineer, Head Works & Tunnel Division, Pallivasal Extension Scheme, Kerala State Electricity Board Ltd., Munnar has furnished the undertakings mentioning that they undertake to shift the water pipeline, if required by Highway Authority at any time for expansion of road at their own cost.
