Sub: Proposal for access permission for approach roads at km 240/285 to 240/320 (RHS) on NH-26 to the proposed Retail Outlet of Smt. Sharda Agrawal (Applicant of HPCL) at Mouza-Bangomunda, Tahasil-Koksara, Dist-Kalahandi in the state of Odisha-reg.

1. Smt. Sharda Agrawal (applicant of HPCL), i.e., the applicant, vide letter dated 22.01.2020 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to an "intersection with Rural Roads/ approach roads to private and public properties" is at a distance of 130 m as against the norm of minimum distance 300 m.
2. As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to invite public comments, for a period of 60 days.
3. In view of the above, comments of public, if any, on the above relaxation proposal are invited online as well as in hard copy by enclosing location plan, justification & Form-A. The same should reach to the below mentioned address within 60 days from the date of uploading it, in the website, beyond which no objection will be considered.
