Sub: NHAI, Madurai Region - PIU, Dindigul - Permission for laying water supply pipeline along NH from Km 223/025 to Km 224/490 (LHS), from Km 224/490 to Km 225/090 (RHS), Km 225/090 to Km 227/450 (LHS) & Km 227/450 to Km 227/626 (RHS) and across NH at Km 224/490, Km 225/090 and Km 227/450 in Dindigul -Theni - Kumuli section of NH220 in the State of Tamil Nadu - Proposal submitted - Regarding.

The proposal is regarding permission laying water supply pipeline along NH from Km 223/025 to Km 224/490 (LHS), from Km 224/490 to Km 225/090 (RHS), Km 225/090 to Km 227/450 (LHS) & Km 227/450 to Km 227/626 (RHS) and across NH at Km 224/490, Km 225/090 and Km 227/450 in Dindigul - Theni - Kumuli section of NH-220 in the State of Tamil Nadu submitted to this office by the PD, NHAI, Dindigul vide letter No. NHAI/PIU/DGL/11014/DTK/NH-45(E) & 220/2020/1200 dated 26.06.2020 (received on 29.06.2020)

The alignment proposed by Executive Engineer, TWAD Board, RWS Division, Theni for laying water supply pipeline along NH from Km 223/025 to Km 224/490 (LHS), from Km 224/490 to Km 225/090 (RHS), Km 225/090 to Km 227/450 (LHS) & Km 227/450 to Km 227/626 (RHS) and across NH at Km 224/490, Km 225/090 and Km 227/450 in Dindigul - Theni - Kumuli section of NH-220 in the State of Tamil Nadu as detailed under:

- 3. The submitted proposal is in conformity with Ministry's latest guidelines, regarding accommodation of public and industrial utility services along and across National Highways, issued vide letter dated 22.11.2016.
- 4. Executive Engineer, TWAD Board, RWS Division, Theni has furnished an undertaking to the effect that TWAD Board, RWS Division, Theni will shift the pipeline if required at any time owing to expansion of the road or if necessary by the NH Authority at their cost & risk without claiming any cost from NHAI. Further, they have furnished an undertaking that other existing utilities will not be damaged and in case, if damaged, then TWAD will pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of pipeline will not have any deleterious effect on any of the bridge components / road way and safety of road traffic.
- 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, RWS Division, Theni will be made available for public comments/objections and the comments will be invited within 30 days from the day of uploading.
