2. HPCL has requested for relaxation for the construction of acceleration/deceleration lane which is required as per clause 6.2.1 of Guidelines issued vide Ministry's circular No. RW/NH-33023/19/99-DO-III dated 24.07.2013.

As per the guidelines issued vide Ministry's circular No. RW/NH-33023/19/99-DO III dated 16.03.2016, the application for relaxation shall be put out on Ministry's website for 60 days for seeking public comments (on grounds of damage to Highway, public inconvenience, safety and general public interest).
