With reference to the subject cited above, it is for your kind information that the applicant M/s Sompuri Infrastructures Pvt. Ltd has submitted proposal for laying 800mm from Ore Siurry Pipeline and 800 mm Water Pipeline from Rimuli to Bileipada (Ch.163+000 Km to 178+350 Km) LHS and 3 no. of crossing at Km 173+000, Km174+000 & Km 178+350 in the utility Corridor of NHAI.

2. In this regard, the site inspection has been conducted by the Authority's Engineer of the subject stretch for checking the feasibility of proposal w.r.t space available in the utility corridor & the proposal has been found feasible at the location. The AE has furnished his comments in the letter under reference 3rd cited.

3. Further, the proposal has been scrutinised in light of the extant guidelines for "Accommodation of Public & Industrial Utilities along and across National Highways" issued vide Ministry Circular RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and Ministry Circulars RW/NH-37011/52/2020/BP3SP dated 15.01.2021 and the proposal has been found to be in order. The details of the Proposal and common's of the PD are as under.

- a) Earlier the ROW Proposal was submitted in the name of M/s Thriveni Earthmover Pvt. Ltd. the approval of Competent Authority was received vide RO Odisha Letter no. 454 dated 06.02.2023
- b) Subsequently, M/s Thriveni Earth movers Pvt. Ltd. has submitted their request for change of jurisdiction to M/s Sompuri Infrastructures Pvt. Ltd. The previous applicant M/s Thriveni Earth Movers has appraised that the necessary clearances from State Govt. HLCA towards transfer of assets like allotted land and other statutory permissions like water drawing permissions, Pipeline permission, etc. has already been transferred in the favour of M/s Sompuri Infrastructures Pvt. Ltd. (Copies of approvals are enclosed for ready reference).
- c) In this context, as per the policy guideline "Ministry Circula: RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and Ministry Circulars RW/NH-37011/52/2020/DP&SP dated 15.01.2021 the above permission which was earlier approved in the Favour of M/s Thriveni Earthmovers Pvt.Ltd. has been resubmitted for approval in the name of M/s Sompuri Infrastructures Pvt. Ltd. as a fresh/New proposal.

- d) The previous applicant M/s Thriveni Earthmovers Pvt. Ltd. has requested for transfer of Utilisation of ROW (Utility Corridor) of the NH-215(New NH-520) for laying Pipelines in the favour of M/s Sompuri Infrastructures Pvt. Ltd. and the same will s been proposed to cater the iron ore slurry & Return water movement. The Request has been made by POA holder Mr. R.K. Mittal of Thriveni vide Board meeting dated 26.10.2019. (POA copy enclosed)
- e) The proposed slurry pipeline starts from Km 163+000 in LHS and ends at Km 178+350 in LHS along with 3 nos of Crossings at Km 173+000, Km 174+000 and Km 178+350. The total width of corridor required is 1750mm from Km 163+000 to Km 174+000 & 900 mm corridor for Km 174+000 to Km 178+350 along the ROW. The details are as under.

- f) Cased Crossing to be done by HDD Method from edge to edge of ROW.
- g) There are three nos. of Crossings at Km 185+205 and at Km 200+150 and both are at minimum distance of 15 meter from the existing structure.
- h) At the VUP Locations & Built up areas, the agency will lay the pipeline after the Toe and drain.
- i) The excavation of trench shall be done with care without harming the avenue plantation.
- j) The applicant has submitted the requisite drawings, documents, undertakings as per the guidelines and the proposal has been found to be in order.
- k) Further, the applicant has also submitted an undertaking stating that in case of non-availability of ROW along the stretch, NHAI will not be held responsible and the applicant will not make any claim thereto.
- The Authority's Engineers have checked the feasibility on their respective site and recommended the proposal for approval of Competent Authority.

4. In view of the above, the proposal of M/s Sompuri Infrastructures Pvt. Ltd. is herewith submitted and is recommended for approval of the Competent Authority for the subject work.
