INVITATION OF PUBLIC COMMENTS

Sub: NHAI, RO Madurai - PIU- Dindigul - Permission for laying of underground water Pipeline by (For Agriculture Purpose) along the extreme edge of the NH boundary from Km 100+490 (RHS) to Km 103+740 (RHS) and across Km 100+720 in Kolarpatti & Gomangalam Villages, Pollachi Taluk, Coimbatore District - Madathukulam to Pollachi section of NH-209 (New No.83) in the state of Tamilnadu- **Invitation of Public Comments - Reg.**

The Proposal is regarding permission for laying of water supply pipeline from

a. Along the road by open trench method in the following chainages:
Km 100+490 to Km 103+740 (RHS)

b. Across the road by trenchless method in the following chainages:
Km 100+720

The laying of water pipeline has been proposed in Madathukulam to Pollachi section of NH-209 (New No.83) by Sh. R. Raghu & Sh. R. Ramesh Coimbatore.

2) Sh. R. Raghu & Sh. R. Ramesh Coimbatore has proposed to lay the Water supply pipeline for a length of 3310 m along the edge of the ROW, at a distance of 1.75m from ROW edge and across the project at 01 location at a depth of 1.2m below ground level. The proposal is in conformity with Ministry's guidelines vide letter No.RW/NH33044/29/2015/ S&R(R) dated 22.11.2016.

3) Sh. R. Raghu & Sh. R. Ramesh Coimbatore has mentioned that the Water supply pipeline along the NH by Open Trench Method at a depth of 1.2m for along portion and by HDD at a depth of 1.20m for across portion.

4) Sh. R. Raghu & Sh. R. Ramesh Coimbatore has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that Sh. R. Raghu & Sh. R. Ramesh Coimbatore will also restore the surfaces to its original condition soon after removal of the Water supply pipelines
