Invitation of Public Comments

Sub: Proposal for access permission for approach roads at km 316/400 to 316/435 (RHS) on NH-49 to the proposed Retail Outlet of Shri Nalinikanta Mohanty (applicant of IOCL) at Mouza-Kuchinda, PS/Tahasil-Kuchinda, Dist-Sambalpur in the state of Odisha-reg.

1. Shri. Nalinikanta Mohanty (applicant of IOCL), i.e., the applicant, vide letter dated 03.03.2020 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to an "intersection with any category of roads of carriageway width of 3.5 m and above" is 18 m as against the norm of minimum distance 300 m and another relaxation with respect to an "intersection with roads of carriageway width of less than 3.5 m" is at a distance of 50 m as against the norm of minimum distance 100 m.
2. As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to invite public comments, for a period of 60 days.
3. In view of the above, comments of public, if any, on the above relaxation proposal are invited online as well as in hard copy by enclosing location plan, justification & Form-A. The same should reach to the below mentioned address within 60 days from the date of uploading it, in the website, beyond which no objection will be considered.

Odisha	49	316/400 TO 316/435(RHS)	Mr. Nalinikanta Mohanty	(i) The distance of proposed retail outlet from intersection with any category of roads of carriageway width of 3.5m and above is 18m against 300m [at Sl. No. 1.2.1-(i) of check list]. (ii) Intersection with roads of carriageway width of less than 3.5m. is 50m against 100m [at Sl. No. 1.2.1-(ii) of check list]	As the roads having too less traffic as the roads are connecting to small villages nearby with less population. These roads are being used by only cyclist, motorcyclist, pedestrians, LMV and no heavy vehicles ply on these roads which shall not disturb NH traffic. More over, three shall not be any traffic hindrance as I shall provide proper signs and markings and also shall ensure all safety aspects.
