Project Director, NHA, PIU-Dhanbad vide letter no. 11015/5/PD/DHN/UL-OFC/1327 dated 09.09.2019 has forwarded the subject project proposal to MoRT&H with recommendation for granting license for use of National Highway land. MoRT&H vide letter no. RW/OFC/02/2019-20/JHR/722 dated 13.11.2019 has forwarded the said proposal mentioning that as per Gazette Notification published vide S.O 3293(E) dated 16.09.2019, RO (MoRT&H), RO (NHA) and ED (NHIDCL) shall exercise the powers conferred under section 25, 28, 31 and 43 of the NH (Land and Traffic) Act, 2002 in respect of their respective territorial jurisdiction.

As per Ministry circular issued vide OM no. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration shall make available the proposal for granting license for use of National Highway land for laying utility service for public comments for 30 days on ground of public interest.

In view of the above, comments of general public is hereby invited on subject captioned proposal, which should reach by this office within 30 days from the date of publication, beyond which no comments shall be entertained.
