- 1. The provisional NOC to the instant proposal was granted by the Ministry's headquarter vide letter no NH-12017/05/2013/UP/NH-II dated 08.05.2013. This office vide letter no RO/LKO/PP/Common/2013-14/594 dated 09.04.2015 had granted extension for provisional NOC up to 08.05.2015. However, as per Ministry's circular dated 24.07.2013, it is stipulated that "in case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority". Thus, it is seen that that there is delay in construction of the instant retail outlet and involves deviation from the Ministry's extant guidelines.
- 2. The Oil Company M/s HPCL has submitted justifications for the delay, wherein it is mentioned that:
- (i) Due to delay in obtaining NOC from DM and forest department. The entire site was flooded due to water logging, so the construction work was delayed.
- 3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
- 4. In view of the above, comments of the public on the above relaxation proposal because of non-fulfillment of completion of the criteria of construction with stipulated time-period, is invited to the below mentioned address:
