Invitation of public comments

Sub.: Proposal for NOC for access permission to the CNG station on NH-24 in Km. 143 (Ch. 142.314, RHS) at Village - Dhannupura, Tehsil & District-Moradabad in the State of Uttar Pradesh - Reg.

The Regional Officer (CGM), UP-West, NHAI, Lucknow vide letter no. 19001/1/RO-W-UP/NH-24/NOC/2986 dated 25.05.2018 has submitted a proposal for issue of provisional NOC for access road permission to the proposed fuel station mentioned in subject.

2. From the submitted location plan, it is noted that there are two roads of 3m and 5m width, adjacent to the proposed retail outlet on either side. Thus, the proposal in its present form does not conform to Ministry's guidelines dated 24.07.2013, Clause 4.5.1.1(ii), wherein it is stipulated that the minimum distance of intersection with rural roads from the retail outlet shall be 300m.

2.1 The Oil Company has requested for relaxation in view of para 2 above, which has been duly recommended by Regional Officer (CGM), UP-West, NHAI, Lucknow. The reasons for relaxation as recommended by Project Director, PIU, NHAI, Aligarh are as follows:

(i) Applicant has proposed to construct a 7m wide and 750m long service road including deceleration/acceleration lane with separator which is covering intersections.

(ii) Both roads terminates at few houses/abadi.

(iii) Only cyclists/motor cyclists & pedestrians use these earthen tracks, no LMV/heavy vehicles ply on these roads. Therefore, there is minimum traffic on these roads without disturbing NH traffic.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).


