Sub.: Proposal for final formal permission and signing of license deed for access to the fuel station of M/s Essar Oil Limited in Km. 78 (Ch. 77.013, LHS) on NH-330 (Old NH-96) at Village - Pakri, Tehsil - Sadar & District - Sultanpur in the State of Uttar Pradesh - Time Extension - Reg.

1. The provisional NOC for the instant retail outlet was granted by this office vide letter no. RO/LKO/HA/NH-330(96)/Km.77.013/2015/1055 (a) dated 24.06. 2015 with the condition that "in case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority."

Earlier, this office vide letter dated 21.03.2017 had approved the extension of time of provisional NOC upto 23.06.2017 with respect to subject cited retail outlet. The Executive Engineer vide his work completion certificate dated 10.01.2019 has certified that the construction work was completed on 08.03.2018 as per approved drawing by the Ministry. Thus, it is seen that that there is delay in construction of the instant retail outlet and involves deviation from the Ministry's extant guidelines.

- 2. As the construction is not completed within 2 years of the provisional NOC, the oil company has requested for relaxation towards delay in completion of the construction work on the following ground, duly recommended by State PWD:
- (i) NOC from forest department has been received on 30.12.2017 and subsequently NOC from DM received on 27.01.2018 i.e. around 2 years, 8 months & 3 days after the provisional NOC was issued. This resulted in delay in construction work at fuel station.
- (ii) Thus applicant could not start work immediately on the site in absence of these statutory approvals as budget is approved only when all the statutory approvals are in hand.
- (iii) Construction work has been completed on 08.03.2018 i.e. the proposal was submitted after the elapsed deadline of provisional NOC period.
- 3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
