1. The provisional NOC for the instant retail outlet was granted by this office letter no. RO/LKO/HA/509(93)/107/2014/1240 dated 04.12.2014 with the condition that "in case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority". However, it is seen that the case has been submitted after the elapse of said deadline. In this regard, Regional Officer (CGM), UP-West, NHAI, Lucknow vide letter dated 19.07.2018 has submitted justification for the delay in construction of the instant retail outlet, enclosing therewith format for relaxation in light of the deviation from the extant guidelines.

2. The Oil Company M/s IOCL has sought relaxation for the above mentioned deviation on the following ground:

(i) NOCs from 9 various government departments other than NHAI have to be obtained and finally NOC for development of retail outlet is granted by the concerned District Magistrate. In this case, NOC from DM, Aligarh was granted to M/s IOCL on 25.03.2017, i.e. around 28 months after the provisional NOC was issued by NHAI. M/s IOCL could not start the work immediately on site in absence of these statutory approval.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
