Invitation of public comments

Sub.: Proposal for NOC for access permission to the proposed fuel station of M/s Indian Oil Corporation Ltd. on NH - 730 in Km. 531 (Ch. 530.574, LHS), Village -Dharmauli, Tehsil – Sadar, District – Mahrajganj in the State of Uttar Pradesh – Reg.

The Chief Engineer (NH), UP PWD, Lucknow vide letter no. 621NH/149N/17 dated 13.01.2018 has submitted a proposal for access permission in respect of fuel station mentioned in the subject above.

2. From the drawings submitted with the proposal, it is seen that there is a road at a distance of 110m from the proposed fuel station site. As per Ministry's guidelines dated 24.07.2013, para 4.5.1 (ii), no intersection with rural roads/approach roads to private & public properties should exist within 300m on either side of proposed fuel station.

2.1 The Oil Company has requested for relaxation in view of para 2 above. The reasons for relaxation as recommended by Chief Engineer (NH), UP PWD, Lucknow, are as follows:

(i) 0.3m high and 1.2m wide covered drain has been constructed in-front of chak marg, so it does not intersect with NH.

(ii) Tehsildar Sadar, Mahrajganj has certified that at present instant chak marg is earthen and approaches of to Gata no. 846 & 856, public does not use. No vehicles ply on this chak marg.

(iii) The Oil Company has submitted that they would provide all safety devices, as and when required.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
