The Authorized Signatory M/s EE, UPPTCL, Raibarelly has submitted the proposal for permission for overhead crossing NH-232A (Unnao - Lalganj) 132 KV Sareni - Raghuraj Singh TSS Line at Ch.54.184 in the State of Uttar Pradesh.

- 2. From the submitted proposal, it is seen that the position of Tower is outside of NH ROW. Length of crossing Span is 198m & Towers are at a distance of 83.67m & 86.63m from either side of NH boundry while height of towers is 42.22m in both side. Vertical Clearance between road level & the lowest conductor is 31.03m. Width of available ROW is 49.50m.
- 3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.
