Sub: Proposal for access permission of approach road to proposed new retail outlet of Hindustan Petroleum Corporation Limited at Mouza - Simaria, P.S/Tahsil (Block) - Jasidih, Dist - Deoghar, State - Jharkhand on NH-333 in km 154/553 to km 154/588 (L.H.S) - Provisional NOC reg.

Sir,

Please refer to your office letter no.HPCL/RNRO/SIMARIA/NH-333 dated 12.04.2021 on the subject mentioned proposal. The proposal was earlier submitted vide your office letter no.HPCL/RNRO/Simaria/NH-333 dated 21.08.2020. The proposal was received after site inspection by concerned state RCD authorities vide EE, NH Division, Deoghar letter No.1580 dated 12.11.2020. Further, the requisite documents was submitted vide your letter No. HPCL/RNRO/SIMARIA/NH-333 dated 30.12.2020 and even No dated 12.04.2021 In this regard, following are mentioned:

2. As per extant guidelines, it is to inform that provisional NOC is hereby granted to M/s HPCL in NH-333 at km 154/553 to km 154/588 (LHS), Plot No.14(P), Khata No.-15/2, Mouza - Simaria, Thana - Jasidih, Dist - Deoghar in the State of Jharkhand.
3. The copies of Bharatkosh receipt bearing transaction ref no. 2412200007922 dated 28.12.2020 amounting to Rs.20,000/- for provisional permission fee, receipt bearing transaction ref no. 2812200007215 dated 28.12.2020 amounting to Rs.2,50,000/- for license fee and receipt bearing transaction ref no.0607200002585 dated 06.07.2020 amounting to Rs. 10,000/- as processing fee submitted by the applicant is being sent to Regional Pay and Accounts Officer (NH), Kolkata to deposit the same in Government of India account. It is intimated that in addition to one time license fee, rent may be collected for the use of NH land as per provisions of Highway Administration Rules, 2004 (Land & traffic Act, 2002) as applicable.
4. Accordingly, one set of the layout plan approved by this office is enclosed herewith. One set of layout plan, two original copies of the License Deed and Bank Guarantee in original amounting to Rs.2,50,000/- vide No.0505221BG0000422 dated

24.03.2021 having validity upto 31.03.2025 have been retained in this office. The license deed will be signed only after compliance of following conditions:


(i) The oil company/owner of the property may construct the Fuel Station alongwith its approach road without interfering in any way with the highway traffic within 12 months from the date of issue of Provisional permission for access and shall make provision for drainage, toilet, drinking water facilities signs and marking at his own cost and to the full satisfaction of the highway authorities according to the approved drawings and specification as per Ministry's circular no.RW/NH-33023/01/2017-S&R(R) dated 26.06.2020. The said approach road shall not be brought into use after its completion until highway authorities give a completion certificate after satisfying himself that it has been completed as per the sanctioned drawings and specifications. The fuel station would be energized by the oil company only after final approval has been issued by concerned highway authorities. A copy of the necessary completion certificate issued to the Oil Company may be furnished to this office which should also be confirmed by the Highway Authorities along with the completion as per Para (iii) below. In case the construction is not done in one year, the provisional permission shall be deemed to be cancelled unless extension to the validity of provisional permission for access is granted by the Regional Officer.

(ii) As per Para 11.0 (ii) of the appendix I of Ministry's guidelines dated 26.06.2020 all the retail outlets shall have free drinking water and separate ladies and gents toilet facility as per the policy of Ministry of Road Transport and Highways. However the number and size may vary based on the type of retail outlet. Therefore, Oil Company should also ensure that all the retail outlets are provided with such facilities and this would be accessible to public round the clock. To inform public about this, a display board showing location of such facilities shall be installed before entry to the retail outlet. This will be implemented prior to energizing the new retail outlet.

(iii) The Highway Authorities should examine the safety conditions at site consequent to construction of approaches. In case of any adverse conditions, the matter may be reported to this office. Compliance to the approved drawings and other conditions are to be ensured by the concerned Highway Authorities and the Oil Company as per extant Ministry's guidelines.
