Invitation of public comments

Sub.: Proposal for granting Permission to cross NH-56A&B (Shaheed Path) MDPE Pipe at Ch.20.250 to Ch.20.350, approx length 100 mtr) to lay 125mm MDPE Pipeline by trenchless (HDD) method in front of Bhukhand Vihar.

The Manager (P,O & M), Green Gas Limited, Lucknow has submitted proposal through PIU-Lucknow letter dated 13.10.2020 & 25.01.2021, for granting Permission for underground crossing through HDD method to lay 125mm MDPE Pipeline at subject cited chainages/ stretch through HDD method.

2. From the submitted proposal, it is seen that the utility will be laid across the NH through trenchless (HDD) method and will be laid at the extreme edge of ROW at the depth of minimum 3 M from surface of road at/from Ch.20.250 to Ch.20.350. The width of ROW from centre line at the crossing/laying stretch location is 30 M on either side. In this connection, Manager (P,O & M), Green Gas Limited, Lucknow has undertaken that they will confirm all standard condition of Ministry Circulars and NHA's guidelines for crossing.






The permission for laying of Gas Pipe Line shall be considered for approval /rejection based on the Ministry Circulars mentioned as above.

(a) Carrying of swage/gas pipelines on Highway Bridges shall not be permitted as Fumes/gases pipes can accelerate the process of corrosion or may cause explosions, thus, being much more injurious than leakage of water.
