The permission for laying of Gas Pipe Line shall be considered for approval / rejection based on the Ministry Circulars mentioned as above,

Carrying of sewage/**gas pipelines** on highway Bridges shall not be permitted as Furnes/gases pipes can accelerate the process of corrosion or may cause explosions, thus, being much more injurious than leakage of water.

Services are not being allowed indiscriminately on the parapet/any part of the bridges, Safety of the bridges has to be kept in view while permitting various services along bridge.


